## Tournament Rules

1. Entry fee covers insurance and all entry requirements.
2. Age as of December 31, 2014.
3. PIAA and PJW rules apply to applicants, coaches, and spectators.
4. Periods- 1:30/1:30/1:30 (Championship Bouts)  
OT- 1:00/:30/:30 (Ultimate Tie Breaker)
5. Headgear is required (no tape). Shoelaces must be secured
6. Mouth guard is required to cover braces. Hair rule per PIAA rules.
7. Suitable undergarment must be worn during weigh-ins.
8. No weight changes are permitted after the close of Registration. Wrestlers not making weight will be scratched and no refunds will be issued.
9. Wrestler must reside in one of the following counties: Berks, Dauphin, Lancaster, or Lebanon.
10. Birth certificate and proof of residency must be provided if challenged.
11. No hats are permitted by wrestlers, coaches, or spectators in the mat area.
12. 1st, 2nd, and 3rd place finishers qualify to advance to the State Championships February 28th and March 1st @ the Hersheypark Area, Hershey, PA.
13. Advancing wrestlers MUST pay a \$90 deposit for a mandatory singlet, shorts, and tee shirt. Singlets may be returned for a \$40 refund.
14. Failure to comply with any stated or assumed rules will result in disciplinary action.
